After the contact sessions, students undertake a variety of formative assessments, practical exercises, observations of processes at the CCMA, and written assignments over two (2) months. All the semester work is concluded with final examinations at the end of the semester (May-June) and (November) each year. Students have the option to take two courses each semester to complete the programme or take individual courses per semester until the bridging course (if needed) and all the four courses are completed. #### FOUNDATIONS OF COMMERCIAL LAW PRACTICE

Description	The Foundations of Commercial Law Practice aims to bridge the gap between participants' existing knowledge and courses in Labour Dispute Resolution Practice (LDRP) courses. It aims to equip students with critical thinking skills, legal reasoning skills, legal reading skills for legislation and case law, effective writing skills and legal problem solving skills. The course also aims to provide opportunities to interact, and to stimulate thinking on specific topics. This will collectively prepare participants for LDRP studies.
Outcomes	<ul> <li>At the end of the course students should be able to:</li> <li>Interpret (i) the meaning and purpose of law; (ii) the social contract; and (iii) the law in context and in relation to related concepts such as morals, religion, culture and justice.</li> <li>Identify (i) primary and secondary sources of law; (ii) the hierarchy of the South African courts and the applicable rules of judicial precedent as a sources of law; (iii) the various branches of law.</li> <li>Distinguish between (i) a criminal case and a civil case; (ii) substantive and procedural law; (iii) public and private law; (iv) foreign law and international law.</li> <li>Clarify (i) the requirements for a valid contract; (ii) the forms of breach of contract and the legal remedies for a breach of contract; (iii) definition and requirements for a valid contract of sale; (iv) the definition and requirements for a valid contract of sale, agency; (v) the definition and requirements for a valid contract of sale, agency and employment.</li> <li>Outline the definition and elements of a delict insofar as they intersect with the law of contract and labour law.</li> </ul>

#### INDIVIDUAL LABOUR LAW PRACTICE

Description	The Individual Labour Law Practice postgraduate certificate course examines individual Labour Law rights in South Africa. To this end it focuses on common law contractual rights, the Constitution of the Republic of South Africa, 1996 ('the Constitution') and statutory protection in terms of the Labour Relations Act 66 of 1995, the Basic Conditions of Employment Act 75 of 1997, the Employment Equity Act 55 of 1998, the Skills Development Act 97 of 1998 and the Occupational Health and Safety Act 85 of 1993. This course can be taken on its own or as part of the Labour Dispute Resolution practice certificate course.
Outcomes	<ul> <li>At the end of the course students should be able to:</li> <li>Discuss the history of the struggle for individual Labour Law rights and its provisions in the Constitution</li> <li>Explain the various sources of Labour Law</li> <li>Define and discuss the scope of basic rights and duties arising from the Labour Relations Act</li> <li>Identify who an employee is</li> <li>Appraise and distinguish key provisions and rights arising from the Basic conditions of Employment Act and the Skills Development Act</li> <li>Appraise and distinguish the concept of employment equity and key provisions pertaining to affirmative action and unfair discrimination</li> <li>At the end of the course students should be able to:</li> <li>Assess and evaluate the meaning of dismissal and the procedural and substantive requirements that need to be satisfied when dismissing an employee for misconduct, incapacity or operational requirements</li> <li>Discuss, analyse and evaluate what an unfair labour practice is</li> <li>Distinguish between the relevant remedies that are available to an employee who has been unfairly dismissed, and</li> <li>Discuss, analyse and evaluate the dispute resolution process applicable in individual Labour Law disputes.</li> </ul>

## COLLECTIVE LABOUR LAW PRACTICE AND JURISDICTION

Description	The Collective Labour Law Practice and Jurisdiction postgraduate certificate course examines collective Labour Law rights and jurisdiction in South Africa. To this end it focuses on common law rights, the Constitution and statutory protection. The course further reflects on freedom of association and collective bargaining, Bargaining Councils, statutory councils, trade unions and employer organisations. Assess and evaluate rulings pertaining to subject matter jurisdiction, employment relationships, time violations and territorial jurisdiction. This course can be taken on its own or as part of the Labour Dispute Resolution practice certificate course.
Outcomes	<ul> <li>At the end of the course students should be able to:</li> <li>Define and discuss the meaning of collective bargaining</li> <li>Appraise and distinguish the role that collective bargaining plays in the Constitution and various other legislation</li> <li>Discuss and analyse the following: freedom of association, Bargaining Councils, statutory councils, organisational rights, union security arrangements, the right to strike and workplace forums</li> <li>Define jurisdiction and interpret the guidelines in conducing jurisdictional applications, and</li> <li>Assess and evaluate rulings pertaining to subject matter jurisdiction, employment relationships, time violations and territorial jurisdiction.</li> </ul>

Conciliation within various sectors is reflected on within a global context, the Constitution and relevant legislation. The course covers the most recent policy and jurisprudential developments in dispute resolution. The course concludes by affording students the opportunity to learn how conciliation works in practice through simulation exercises. This course can be taken on its own or as part of the Labour Dispute Resolution practice certificate course.
Outcomes	<ul> <li>At the end of the course students should be able to:</li> <li>Discuss the different dispute resolution processes</li> <li>Define the conciliation processes</li> <li>Explain conciliation within the global context, the Constitution and the legislative framework</li> <li>Differentiate between rights verses interest disputes, and rights verses position</li> <li>Discuss, analyse and evaluate the principles of ethics involved in conciliation</li> <li>Conduct an effective conciliation process and draft settlement agreements, and</li> <li>Prepare the necessary reports and settlement agreements.</li> </ul>

Arbitration within various sectors is reflected on within a global context, the Constitution and the legislative framework. The course covers the most recent policy and jurisprudential developments in arbitration proceedings. The course concludes by affording students the opportunity to learn how arbitrations works in practice through simulation exercises. This course can be taken on its own or as part of the Labour Dispute Resolution practice certificate course.
Outcomes	<ul> <li>At the end of the course students should be able to:</li> <li>Discuss the arbitration process</li> <li>Define the scope of the arbitrator's Code of Conduct and fairness in the arbitration process</li> <li>Explain arbitration within different contexts including the global context, the Constitution and the legislative framework</li> <li>Appraise and distinguish between several issues in arbitration, including jurisdictional matters and when legal representation is permissible</li> <li>Conduct an effective arbitration process</li> <li>Draft an arbitration award, and</li> <li>Prepare the relevant rulings.</li> </ul>
