The next 1,000 days

Building on early investments for the health and development of young children



Why the next 1,000 days matter?

- Period of significant growth of skills.
- Sensitive window of opportunity to mitigate environmental risks, promote protective factors, and establish healthy developmental and behavioural trajectories.
- Chance to sustain and build on gains in the first 1,000 days, and recalibrate trajectories where opportunities were lost in previous 1,000 days.





Environments that shape young children's development: *Biological, Family, ECCE* & *Climate*

- 1. Build on parenting investments from the first 1,000 days to the next 1,000 days
- 2. Access, equity and quality to care and early learning outside of the home matter
- 3. Advance multi-sector actions
- 4. Pay more attention to developmental disabilities, and impacts of climate change and pollution



Estimates of young children's access to nurturing care and development:

- Only 1 in 4 children (3-4y) receive adequate nurturing care in LMICs
- Children who have received early learning support and responsive care are ~2 years ahead in development
- Most ECD interventions from high-income western countries



Conclusions

- Development in the next 1,000 days:
 - Multidimensional, cumulative and continuous.
- More evidence needed:
 - Environments influencing development in the next 1,000 days.
 - Disaggregation of findings salient to next 1,000 days.
 - More from LMICs, vulnerabilities to climate change, etc.
- Leverage partnerships across platforms.
 - Shift from health platforms, shift in stakeholders.







What works for children in the next 1000 days?

- Effectiveness studies primarily focus on: cash transfers, ECCE, nutritional interventions, parent interventions & multicomponent ones.
 - Comprehensive review: 100 studies (951 impact estimates) across the globe.
 - Strong impacts on children's development.
 - Positive Impacts observed across regions of the world & across multiple child development domains & longterm outcomes.
- New publicly available datasets increasingly also allow assessing ECCE long-term effectiveness across countries: PISA & Young Lives.
 - In PISA, children with at least <u>one</u> year of ECCE had higher scores for mathematics & reading.
 - In Young Lives, children exposed to ECCE had higher math scores at age 15 & age 19 and were 6%pts less likely to consume alcohol at ages 15 & 21.
- We also find consistent associations between executive function and socioemotional skills in early life and adolescent school test performance in a review on long-term outcomes.

Key messages...

- The next 1000 days are a key period for children's development and to build on the first 1000 days.
- Robust and rapidly growing evidence highlight shortterm & long-term benefits of interventions specific to the next 1000 days.
- ECCE services can serve as key platform for promotion of healthy behaviours, growth & developmental monitoring, as well as nutritional supplementation.
- Access to ECCE remains globally <u>low</u>, particularly in lowincome countries.

- Providing <u>one year of ECCE</u> to all children costs on average less than 1% of GDP.
- The benefits of providing this <u>one year of ECCE</u> to all children are on average 8–19x larger than the cost of implementing these across LMICs.
- Most Critically, Increased attention on the next 1000 days is imperative for the achievement of the SDGs, and the time for global action is <u>NOW!</u>
