





AI & African Music Project Pilot

Application guidelines and Frequently Asked Questions (FAQs)

1. What's this about?

The Wits Innovation Centre (WIC) and the MIND Institute invite proposals for bold, music-led projects that place African creativity at the heart of artificial intelligence. We support initiatives in music-making, archiving, education, and tool development—rooted in African sounds, languages, and innovation.

2. Who Can Apply? Applicants must:

- Be of African heritage and permanently based/living in an African country
- Work professionally in music (e.g. musicians, producers, composers, educators)
- Be available and able to travel to Johannesburg, South Africa in November 2025 and April 2026
- Be willing to be publicly profiled
- Meet financial compliance requirements (see below)

3. Key Dates and Links

4. What You Need to Submit

- Project Description (max 500 words): Outline your idea, goals, and how it aligns with one or more of the four project themes below, or another important area that highlights an opportunity in music and technology/AI
- Bio, CV and portfolio of past work: Submit credible, publicly accessible online links only (e.g. YouTube, SoundCloud, Bandcamp, Spotify, personal website)
 Do not upload files or send downloadable documents, videos or audio files
- Note: Applications for the pilot will be accepted in English only
 - **5.** What We're Looking For Your proposal should ideally align with one or more of these four focus areas:

Theme	Opportunity
Creative Practice & Collaboration: Use AI to cocreate, perform, and teach music rooted in African traditions	Artistic creation, performance, teaching, and genre innovation using AI
Record, transcribe, and preserve African musical works—from oral heritage to digital formats	Safeguarding African musical heritage through or with Al
Build and localize AI tools that understand African sounds, languages, and workflow	Developing culturally relevant and technically sound AI tools
Remix and reimagine genres (like Amapiano, Afrobeats, Gqom, heritage genres etc.)	Genre evolution and experimentation with Al







6. Selection Criteria

- Relevant skills for achieving and delivering the proposed project
- Local or regional relevance and transformation potential
- Consideration for human creativity in AI
- Novelty, scalability, and market impact
- Demonstrable experience or exceptional talent in music and relevant area

7. What You'll Receive and Participate In:

- ZAR 30,000/month for 4–6 months (to be determined if selected for award)
- Support from an Al collaborator you can propose an engineer for our consideration or we will allocate one who can support the project; there is a limited stipend available for engineers to be contracted separately
- Workshop in Johannesburg (November 2025 incl. travel and limited related costs such as visa support, accommodation, meals and event access)
- Monthly advisor check-ins a mentor will be allocated to each awarded musicianengineer team and monthly meetings + reporting will be required
- Community of Practice regular meetings with all awarded musicians/creators and engineers will be scheduled to provide group learning and exchange around progress and challenges, and to assist with ongoing advice and build team and network engagement
- Production support for showcase limited production support will be provided to help you prepare your project for presentation during the April 2026 workshop and showcase event and for further presentation/promotion
- Final showcase (April 2026 incl. travel and limited related costs such as visa support, accommodation, meals and event access))

8. Financial Compliance Requirements – If selected, you must:

- Sign a formal agreement with Wits University via Wits Commercial Enterprise (Pty) Ltd, outlining and committing to project deliverables and milestones
- Provide the following documentation:
 - o Proof of bank account (official bank letterhead, stamped and signed)
 - Letter of identity and banking details (on official letterhead if contracting via a company)
 - o Certified copy of passport and residency/visa documentation
 - Company registration documents (if contracting through a registered entity)

9. Disqualification Criteria – Applications will be excluded if:

- You do not submit an EOI or attend an info session
- Your project does not align with the four themes or clearly demonstrate and describe how it aligns with an alternative thematic area relevant to the project objectives as outlined
- You are not based in Africa
- You cannot travel to South Africa for the project launch and showcase workshops
- Your application is incomplete, late, or submitted via non-approved channels
- You cannot meet financial compliance requirements
